## Our commitment is to:

- Continuously improve our environmental performance and integrate recognised environmental management best practices into our business operations.
- Reduce our consumption of resources and improve the efficient use of those resources.
- Measure and take action to reduce the carbon footprint of our business activities to meet our objectives and targets to become Carbon Neutral by the end of 2022.
- Manage waste generated from our business operations incorporating reduction, reuse and recycling following the principles of the waste hierarchy.

  of the company and training records are held; training will be provided initially during
  induction and as required thereafter. Further training will be required should the
  scope of works undertaken by the Company change and/or following monitoring of
  the Environmental Procedures for continual improvement.
- Ensure that all subcontractors/suppliers working on our behalf hold appropriate environmental permits/licenses (e.g. asbestos removal, waste carrier, etc).
- Ensure that timber/timber products are supplied with CPET Category A / B evidence as appropriate.
- Promote appropriate consideration of sustainability and environmental issues in the services we provide to our clients such as 'Zero Waste Criteria' and 'Amenity Standard'.
- Monitor external environmental impacts and ensure the company's resilience to the potential risks.
- Review our environmental policy regularly.
